#### 1. ONSAFX PRIVACY POLICY

OnsaFx (Pty) Ltd is a company registered and headquartered in South Africa (registration number: 2023/648987/07), and a financial service provider authorised and regulated by the Financial Sector Conduct Authority ("FSCA") under FSP license number FCSA 53192, governed by the Financial Advisory and Intermediary Services Act, 2002 (Act No. 37 of 2002). OnsaFx Ltd, registered in the Republic of Cyprus with registration number HE436466 and registered address at Archbishop Makarios III, 160, Floor 1, 3026, Limassol, Cyprus. ("we", "us" or "OnsaFx"). OnsaFx Ltd is acting as OnsaFx (PTY) Ltd appointed independent representative and distributor.

#### 2. COMMITMENT

OnsaFx is committed to protecting the privacy of all personal information which it obtains from you, including the information obtained during your visits to this website or the provision of other services to you. OnsaFx will only use your personal information in accordance with this Privacy and Security Policy and otherwise in accordance with the Protection of Personal Information Act, 2013, as amended from time to time.

#### 3. ONSAFX COLLECTS PERSONAL INFORMATION

OnsaFx collects certain personal information in order that it may meet the needs of its customers. By collecting certain personal information, OnsaFx can monitor and improve the services it offers to its existing and potential customers. We will use this information for the following purposes: establishing and maintaining your account, providing our services to you, improving our services, regulatory notifications, and marketing.

# 4. WHAT INFORMATION DOES ONSAFX MARKETS OBTAIN? OnsaFx will collect and hold information about you when you complete an online application or other type of form or access and trade on your account through this website or another service we provide to you. OnsaFx may derive information from your use of this website or another service we provide to you and may store this information with your personal profile. This information may include site areas visited, pages viewed, frequency and duration of visits, types of transactions conducted, documents downloaded, and other websites which may have referred you or to which you link.

#### 5. HOW WILL ONSAFX USE THIS INFORMATION?

OnsaFx may use such information for any one or more of the following purposes:

- to provide the services to you that you have requested including processing transactions.
- to confirm your identity.

- to maintain your personal profile; to manage your account.
- to contact you when necessary or appropriate in relation to the services being provided to you.
- to keep you updated whilst you are a customer in relation to matters such as contracts you have traded and activities of OnsaFx.
- to manage and administer the products and services provided to you.
- to provide you with information regarding the products and services offered by OnsaFx; to develop an understanding of the products and services that you may be interested in obtaining from OnsaFx.
- to provide you with information or opportunities that we believe may be relevant to you.
- to tailor the website or other service we provide to you to your needs and interests; and
- to create anonymised statistical data.

You consent to OnsaFx using your personal information for the above-stated purposes. You also consent to OnsaFx transferring your personal information out of South Africa where this is necessary for OnsaFx to fulfill its contractual obligations to you. Please note that OnsaFx only transfers personal information to organisations outside of South Africa if OnsaFx has assessed the organisation as having appropriate controls and safeguards in place to protect your personal data.

#### 6. WHO MAY ONSAFX DISCLOSE THIS INFORMATION TO?

OnsaFx may be required to provide your personal information to the regulator and government bodies from time to time. OnsaFx may also disclose your personal information to:

- financial institutions and other similar organisations that ideals within the course of its corporate activities, or those that are nominated by you.
- external service providers and professional advisers (which may be located overseas) that provide services to OnsaFx.
- any organisation at your request or any persons acting on your behalf, including your financial adviser, broker, solicitor or accountant.
- any third parties where this is necessary to process a transaction or provide services which you have requested; or
- any authority to whom OnsaFx is required to disclose such information by law. Please note that OnsaFx does not sell or provide your personal information to third parties for marketing purposes.

#### 7. UPDATING YOUR INFORMATION

We may charge a nominal fee to cover the cost of verifying the application and locating, retrieving, reviewing and copying any material requested.
